A-33 EMERGENCY ENGINE/PROPULSION CUT-OFF DEVICES

Based on ABYC's assessment of the existing technology, and the problems associated with achieving the goals of this standard, ABYC recommends compliance with this standard for all boats, associated equipment, and systems manufactured or installed after July 31, 2019.

33.1 **PURPOSE**

This standard is a guide for the design, construction, installation and performance of devices used to disable the propulsion system when the operator is unexpectedly displaced from the boat and may include provisions to alert the operator when passengers are unexpectedly displaced from the boat.

33.2 **SCOPE**

This standard applies to all mechanically powered boats equipped with devices that disable propulsion when the operator is unexpectedly displaced from the boat and boats equipped with a warning system for passengers unexpectedly displaced from the boat.

NOTE: These methods are not intended to offer instantaneous protection if the occupant/operator falls into the path of the boat.

33.4 **DEFINITIONS**

For the purpose of this standard the following definitions apply.

- 33.4.1 Emergency Cut-Off Device a switch or other system that, when activated in an emergency, provides the means to stop the mechanical propulsion system.
- 33.4.2 Mechanical Lanyard a device designed to attach the operator to the system that stops the engine under emergency conditions.
- 33.4.3 Passenger Protection Device a system intended to alert the operator of unexpected passenger displacement from the boat.
- 33.4.4 Readily Accessible capable of being reached quickly and safely for effective use under emergency conditions without the use of tools.

33.5 **GENERAL REQUIREMENTS**

33.5.1 The device manufacturer shall provide installation instructions.
