BACKGROUND

This technical information report includes elements to consider in the development of owner/operator's manuals for boats. The intent is that owner/operator's manuals give sufficient information regarding the owner/operator's responsibility, and proper operation and maintenance of the boat. Further, the intent is that the development of owner/operator's manuals be done with careful consideration of all elements relating to the specific boat model to which the manual applies. This report provides a guideline for writing owner/operator's manuals. This guideline does not require that each and every item listed in this report be in the manual. The writer of an owner/operator's manual should consider each of the points raised in this document and include in the manual for a given boat only those items which are pertinent to that vessel.

INTENT

This technical information report applies to all recreational boats.

DEFINITIONS

For the purposes of this report the following definitions apply.

Owner/operator's Manual - A compilation of information provided by the boat manufacturer, including all available component manuals.

CONTENTS

It is recommended that all safety-related copy be graphically emphasized in the owner/operator's manual.

- b. Declaration Statement Statement of the standards to which the boat was built.
- c. Owner/operator's Responsibilities
 - (1) Federal law and the laws of most states clearly specify that the operator of a vessel is responsible for the maintenance and safe conduct of the vessel and the safety of passengers.
 - (2) State registration or federal documentation.
 - (3) Safety equipment required and/or recommended by the USCG.
 - (4) Manufacturer's warranty registration/procedures.
 - (5) Information on boating safety courses, through which operators can gain knowledge and experience in skills such as:
 - (a) navigation,
 - (b) seamanship and boat handling,
 - (c) rules of the road, international inland,
 - (d) weather prediction,
 - (e) safety at sea,
 - (f) survival in bad weather,
 - (g) respect for others on the water,
 - (h) first aid,
 - (i) radio communication,
 - (j) distress signals, and/or
 - (k) pollution controls
