One purpose of these standards is to serve as guides to governmental authorities having jurisdiction over subjects within the scope of the A10 Committee standards. If these standards are adopted for governmental use, the reference of other national codes or standards in individual volumes may be changed to refer to the corresponding regulations.

Revisions: The A10 Committee welcomes proposals for revisions to this standard. Revisions are made to the standard periodically (usually five years from the date of the standard) to incorporate changes that appear necessary or desirable, as demonstrated by experience gained from the application of the standard. Proposals should be as specific as possible, citing the relevant section number(s), the proposed wording, and the reason for the proposal. Pertinent documentation would enable the A10 Committee to process the changes in a more timely manner.

Interpretations: Upon a request in writing to the Secretariat, the A10 Committee will render an interpretation of any requirement of the standard. The request for interpretation should be clear, citing the relevant section number(s) and phrased as a request for a clarification of a specific requirement. Oral interpretations are not provided.

AMERICAN NATIONAL STANDARD A10.39 CONSTRUCTION SAFETY AND HEALTH AUDIT PROGRAM

1. SCOPE

This standard identifies the minimum performance elements that, when properly utilized, will allow for a competent evaluation of a construction safety and health program. Further, it will identify those areas where systems, records and performance elements are required in order to produce a quality audit.

2. PURPOSE

The purpose of this standard is to establish an internal method of measuring compliance with an organization's written safety and health program requirements.

2.1 Exceptions. In cases of practical difficulty or undue hardship, the responsible authority may grant exceptions to the literal requirements of this standard or permit the use of other devices or methods, but only when it is clearly evident that personnel and equipment protection is assured.

3. DEFINITIONS

3.1 Audit. An examination process designed to verify compliance with an organization's written safety and health program, such as outlined in ANSI/ASSE A10.33 and ANSI/ASSE A10.38.

3.2 Qualified Auditor. For purposes of this standard, a qualified auditor is any individual who by virtue of education, experience and training is qualified to complete a comprehensive safety and health audit.

3.3 Construction Safety and Health Program. A written program developed by the contractor specifically for the work to be performed on the job site by the contractor,

as intended by the guidelines offered in ANSI/ASSE A10.33 and ANSI/ASSE A10.38. The program meets the requirements established by the Project Safety and Health Program, and covers all activities and conditions under the responsibility of the contractor.

3.4 Construction Employer. A firm, corporation or other entity responsible for part or all of the construction work.

3.4.1 Project Constructor. A person, firm or corporation, i.e., the construction manager, general contractor, prime contractor or other entity, as designated in the project documents, responsible for supervising, maintaining, coordinating and controlling all construction work performed on the project.

3.4.2 Contractor. A subcontractor, specialty contractor or other entity as designated in the project documents, responsible for part of the construction process on a construction project.

3.5 Construction Safety Audit System. A set of systematic procedures designed to access, evaluate and measure the performance of a construction employer in compliance with its written safety and health program.

3.6 Audit Activity. Any activity whereby performance requirements containing multiple elements may be structured so that each may be evaluated individually and collectively.

4. SAFETY AUDIT ELEMENTS

4.1 Responsibilities.
