1 Scope

- **1.1** This standard applies to flangeless control valves using a full ball or a segment of a ball and other rotary-stem or sliding-stem flangeless control valves, sizes 3/4 inch (20 mm) through 24 inches (600 mm) for ANSI Classes 150 through 600.
- **1.2** The face-to-face dimensions listed apply only to control valves that will be bolted between flanges.
- **1.3** This standard is not intended to include butterfly valves.

2 Purpose

2.1 The purpose of this standard is to aid users in their piping designs for flangeless control valves by providing valve face-to-face dimensions without giving special consideration to the equipment manufacturer to be used.

3 Definitions
