The standard is a revision of *American National Standard for Limited-Use and Disposable Coveralls -- Size and Labeling Requirements*, ANSI/ISEA 101-1993.

The purpose of this standard is to provide requirements for the performance, finished dimensions, labeling and packaging of limited-use and disposable coveralls.

Changes in this edition include the omission of maximum dimensions and the inclusion of a dynamic fit-test protocol. A wear test report has also been added as Appendix A.

This standard was drafted by the Protective Apparel Group of the International Safety Equipment Association. It was processed and approved for submittal to ANSI by the canvass method. The following organizations recognized as having an interest in the standardization of sizes and labeling for limited-use and disposable coveralls were contacted prior to the approval of this standard.
