## Conveyor belts — Sampling

#### 1 Scope

This International Standard specifies the number of samples to be taken for carrying out acceptance tests on conveyor belts, depending on the overall length ordered by the same user.

It is applicable to a batch of conveyor belts having the same characteristics: quality, width, etc.

#### 2 Definition

For the purposes of this International Standard, the following definition applies.

2.1 acceptance test: Test conducted at the producer's laboratory by or on behalf of the producer or on behalf of the purchaser or user in order to verify compliance with the conditions or requirements of the contract.

### 3 Specification

The number of samples to be taken is given in table 1.

No recommendation is made regarding the place from which the sample shall be taken.

Table 1

Total length of belt ordered ${\it L}$ m	Number of samples
<i>L</i> ≤ 500	1
$500 < L \le 1000$	2
$1000 < L \leqslant 2000$	3
$2000 < L \leqslant 3500$	4
$3500 < L \leqslant 5000$	5
$5000 < L \le 7000$	6
7 000 < <i>L</i> ≤ 10 000	7

NOTE — Above 10 000 m, one additional sample shall be taken for every 5 000 m.

#### 4 Sampling

The test samples shall be of full-belt width and of a sufficient length to carry out all tests requested for the type of belt considered.

The additional lengths required for the test samples shall be included in the total length of the order.
