They can also enable the expression of functional properties in arbitrary units, for instance in certain cases relevant for biology or material sciences. RMs play an important role in national and international standardization activities and in the accreditation of laboratories.

This document defines terms used in connection with the production and use of RMs and certified reference materials (CRMs). It aims to ensure use of consistent terminology by organizations worldwide that work with RMs and CRMs.
