Introduction

This part of ISO 4689 is a new procedure. ISO 4689-2 was originally published as ISO 4690:1986. Under a policy of rationalization of the numbering system used in ISO/TC 102, it has been decided to re-designate ISO 4690:1986 as ISO 4689-2. It was further decided to introduce a combustion/infrared method, numbered ISO 4689-3, i.e. this part of ISO 4689.

When next revised, ISO 4689:1986 will be re-designated as ISO 4689-1.
