This second edition cancels and replaces the first edition (ISO 8080:1985), which has been technically revised.

The main changes compared to the previous edition are as follows:

- the solution temperature has been changed from  $(21 \pm 2)$  °C to  $(20 \pm 5)$  °C (see <u>4.1.3</u>);
- the use of alternative chemical products for the pickling solution has been allowed (see <u>4.1.7</u>);
- higher duration for etching has been allowed (see <u>4.2.5</u>);
- an alternative mechanical activation has been allowed (see <u>4.2.6</u>);
- voltage cycle has been provided only as a recommendation (see <u>4.3.1</u>).
