# 1 Scope

#### 1.1

This Standard covers the following equipment for use in metal heads that are in accordance with the latest revision of ANSI C136.6:

- a. High-intensity discharge lamp ballast and socket assemblies in accordance with Figure 1.
- b. Mogul and medium multiple incandescent lamp socket and support assemblies in accordance with Figure 2.

### 1.2

The purpose of this Standard is to permit mechanical interchangeability of the socket support assemblies.
